STUDENT'S RIGHT TO CANCEL

The School, without penalty or obligation shall refund 100 percent of the amount paid for all school charges, less the amount of \$100 non-refundable registration fee, if a written notice of cancellation is made prior to or on the first day of instruction. Cancellation or any refund request shall be made in writing to: Santiago Rodriguez, Director, America Truck Driving School, Inc.
